### **Policy Statement**

As part of N.I.S Holdings Group, N.I.S Ltd is fully supportive of the laws introduced within the United Kingdom through the Modern Slavery Act 2015 to combat slavery. We take a zero-tolerance approach to forced or compulsory labour and the trafficking of people for any purpose.

N.I.S Ltd expects all employees, suppliers and any third parties that work with N.I.S Ltd to adhere to the same standards and operate with integrity and transparency in all their interactions with their suppliers and sub-tier suppliers and contacts.

## **N.I.S Ltd Structure and its People**

N.I.S Ltd recruitment and people management processes are designed to ensure that all prospective employees are legally entitled to work in the UK and to safeguard employees from any abuse or coercion once in our employment. Baseline clearances are completed for all employees which includes proof of identity.

N.I.S Ltd maintains the following policies that are accessible to all staff via an online IMS (integrated management system) portal which are reviewed regularly in line with legislation:

#### **Training**

Training in the form of awareness will be delivered to the relevant internal stakeholders who operate within areas of the business that modern slavery may be at a higher risk of being witnessed or observed (E.g. Procurement, Human resources, Commercial teams, Mental health first aiders).

## **Supply Chain / Partnerships**

N.I.S Ltd will not carry out business or partnership with any organization which knowingly supports or is found to be involved in slavery, servitude and forced or compulsory labour.

N.I.S Ltd are aware of Conflict Minerals and understand the term to mean materials taken from mines using forced labour and controlled by armed groups. The most widely cited instances having come from the Democratic Republic of Congo and neighbouring countries, where tin, tungsten, tantalum and gold are mined. Other examples of minerals with potential links to conflict include copper, cobalt, platinum and diamonds.

N.I.S Ltd is committed to procuring materials purchased from legitimate sustainable sources using Original Equipment Manufacturers (OEM), well-known steel producing mills and authorised distributor supply chains.



## **N.I.S Ltd Modern Slavery & Human Trafficking**

N.I.S Ltd take a risk-based approach based on categories of supply, values of expenditure and geographic location of the supply base. All N.I.S Ltd's new suppliers and service providers confirm their agreement to adhering to the Modern Slavery requirements by way of signature on N.I.S Ltd supplier questionnaires and Category A (Key suppliers) are monitored during N.I.S Ltd annual assessments. The supplier assessments include questions regarding the existence of a Modern Slavery and Ethical Trading Policy, as well as challenging the supplier on their understanding of the topic and the awareness across their business.

N.I.S Ltd is committed to developing our supply chain and will encourage collaboration to educate and improve.

## N.I.S Ltd.'s commitment to combatting slavery and human trafficking

As of September 2025, N.I.S Ltd intend to take the following steps to combat slavery and human trafficking:

- Ensure that all relevant employees are exposed to Modern Slavery awareness training
- Continue to monitor and review supplier management and controls regarding slavery and Human trafficking
- Review effectiveness of our current actions and explore opportunities for improvement
